

**SUMMARY ANNUAL REPORT FOR
SOUTHERN COMPANY SERVICES, INC. HEALTH AND WELFARE BENEFITS PLAN**

This is a summary of the annual report of the Southern Company Services, Inc. Health and Welfare Benefits Plan, a health, life insurance, dental, temporary disability, long-term disability and death benefits plan (Employer Identification Number 63-0274273, Plan Number 607), for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Southern Company Services, Inc. has committed itself to pay certain Medical claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Gerber Life & Accident Insurance Company, Delta Dental Insurance Company, Metropolitan Life Insurance Company, Provident Life and Accident Insurance Company, Kaiser Foundation Health Plan of Georgia, New Directions Behavioral Health, John Hancock Life Insurance Company and BlueCross BlueShield of Illinois to pay certain Business Travel AD&D, Dental, Group Long - Term Care Insurance, Temporary Disability, Long-Term Disability, Life insurance, AD&D, EAP Program and Health claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$86,620,100.

Because they are so called “experience-rated” contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2021, the premiums paid under such “experience-rated” contracts were \$11,825,865.

Paperwork Reduction Act Statement
